**EMERGENCY AMENDMENT
TO SAN BENITO COUNTY SUPERIOR COURT BAIL SCHEDULE-
#2**

WHEREAS, on March 4, 2020 the Governor of the State of California declared a State of Emergency due to the introduction and spread of the international COVID-10 virus. On March 13, 2020 the President of the United States of America declared a National Emergency.

As of March 17, 2020, the San Benito County Public Health Officer issued an Order applicable to all individuals living in the County of San Benito to Shelter in Place and directing all businesses and governmental agencies to cease non-essential operations within the county, and to prohibit all non-essential gatherings of any numbers of individuals or non-essential travel.

And on March 19, 2020, the Governor of the State of California issued Executive Order N-33-20 ordering all individuals living in the Stat of California to stay home or their place of residence except as needed to maintain continuity of operations of the federal critical infrastructure sectors

On April 6, 2020, the Judicial Council of California took certain actions In response to the COVID-19 crisis, including adopting statewide bail regulations.

The federal, state and local officials have taken these actions to reduce the transmission of the COVID-19 virus in order to protect public health and safety.


Accordingly, the Superior Court of the State of California, County of San Benito hereby amends its Bail Schedule as follows:


1.	All Misdemeanor and Felony violations, with the exceptions specified in paragraph 2 below	Bail=\$0 (Released on own recognizance)
2.	Exceptions:

	<ul style="list-style-type: none">• PC §273.5	Bail=\$6,000
	<ul style="list-style-type: none">• PC §273.6, if the detained person made threats to kill or harm, or has engaged in violence against, or has gone to the residence of workplace of the protected party	Bail=\$8,000

<ul style="list-style-type: none"> VC §23152, with one prior conviction of VC §§23152, 23153, or 23103.5 	Bail=\$0 (Released on own recognizance with substance abuse counseling)
<ul style="list-style-type: none"> VC §23152, with two or more prior conviction of VC §§23152, 23153, or 23103.5 	Bail=\$11,000
<ul style="list-style-type: none"> A serious felony, as defined in Penal Code § 1192.7(c), or a violent felony, as defined in Penal Code § 667.5(c) 	Bail=remain as previously scheduled
<ul style="list-style-type: none"> A felony violation of Penal Code § 69 	Bail=remain as previously scheduled.
<ul style="list-style-type: none"> Penal Code §166(c)(1) 	Bail=remain as previously scheduled.
<ul style="list-style-type: none"> Penal Code §136.1 when punishment is imposed under § 136.1(c) 	Bail=remain as previously scheduled.
<ul style="list-style-type: none"> Penal Code § 262 	Bail=remain as previously scheduled.
<ul style="list-style-type: none"> Penal Code 646.9 	Bail=remain as previously scheduled.
<ul style="list-style-type: none"> A violation of an offense listed in Penal Code §290(c) 	Bail=remain as previously scheduled.
<ul style="list-style-type: none"> Penal Code § 463, as a felony 	Bail=remain as previously scheduled.
<ul style="list-style-type: none"> Penal Code § 29800 	Bail= \$10,000

This amendment to the San Benito County Bail Schedule shall remain in effect for ninety (90) days after the State of Emergency declared by Governor Gavin Newsome on March 4, 2020, ends, unless otherwise modified or repealed.
