Petitioner's February 25, 2026 Request for Order is GRANTED.

Respondent is ordered to pay child support in the amount of \$1,569.00 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Arrears are payable at a rate of \$50 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Each party must pay 50% of child-care costs related to employment or reasonably necessary job training. Each party must pay 50% reasonable uninsured health-care costs for the children.

Respondent is ordered to pay spousal support in the amount of \$541.00 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Arrears are payable at a rate of \$50 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month.
