FL-21-00092 Snyder, Nicole vs. Snyder, Jeremy

The Status Conference, which was scheduled on June 3, 2026, is vacated. The hearing scheduled to take place on September 30, 2026, remains on calendar.

FL-21-00161 Martinez, Flavia vs. Martinez Morales, Melchor

Petitioner's Post Judgment Request for Order seeking Spousal Support is DENIED without prejudice as Petitioner failed to serve a blank responsive declaration and a blank form FL-150 on Respondent, which is required pursuant to California Rule of Court 5.92(f)(4).

FL-21-00240 DeFranco-Soto, Jeannie vs. Soto, Hugo

The Court takes judicial notice of a related case CR-25-00284 and the upcoming trial scheduled for August 17, 2026, that includes charges where Respondent is a listed victim. The Court on its own motion continues the hearings to October 14, 2026, at 8:30 a.m.

FL-22-00158 Robles, Jose vs. Oropeza, Bertha

Respondent's unopposed Motion to Compel Responses to Family Law Form Interrogatories, Set 1 and Request for Production of Documents, Set 1, is GRANTED as requested. Petitioner is ordered to serve complete responses to Form Interrogatories, Set 1, within 10 days. Petitioner is ordered to serve complete responses and produce all responsive documents to Respondent's Request for Production of Documents, Set 1, within 10 days.

Petitioner has waived his right to object to these responses. The Court orders Petitioner to pay \$942.5 in attorney's fees for costs incurred in filing the motion, which shall be payable within 10 days.

FL-25-00059 **Castaneda, Norma vs. Hernandez Reyes, Uziel**

The hearing on Petitioner's June 16, 2026, Request for Order is continued to September 02, 2026, at 8:30 a.m. The parties are ordered to child custody mediation on August 19, 2026, at 9:00 a.m. at the San Benito County Superior Court's Self-Help Center. It appears that the July 8, 2026, mediation did not occur as previously scheduled.

FL-26-00031 **Melchor Romero, Francisco vs. Guzman, Mariela**

The hearing on Respondent's June 24, 2026, Request for Order is continued to September 02, 2026, at 8:30 a.m. The parties are ordered to child custody mediation on August 20, 2026, at 9:00 a.m. at the San Benito County Superior Court's Self-Help Center. It appears that the July 8, 2026, mediation did not occur as previously scheduled.

FL-26-00129 **Juarez, Jayda vs. Barragan, Roman**

Petitioner's June 25, 2026, Request for Order for Child Support is GRANTED. The orders are effective August 1, 2026. Respondent is ordered to pay child support in the amount of \$700 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Each party must pay 50% of child-care costs related to employment or reasonably necessary job training. Each party must pay 50% reasonable uninsured health-care costs for the children.

The court used a printout of a computer calculation and findings, which is located below and incorporated in this order.

Petitioner also requested orders regarding custody and visitation. The parties reached a full agreement as to these issues.
