## Tentative Decisions for August 12, 2026

**Courtroom #1: Judge J. Omar Rodriguez**

**FL-25-00222      Brown, Kelley vs. Zuniga, Camille Kristine**

Respondent's Request for Order seeking Spousal Support is DENIED. Temporary spousal support requires both a showing of need by the supported spouse and ability to pay by the supporting spouse. (*In re Marriage of Pletcher* (2021) 68 Cal. App. 5th 906, 913.) Here, the parties' incomes are comparable. Petitioner's gross monthly income ranges from approximately \$9,143 to \$10,935 depending on overtime, shift differentials, and other variable compensation. Respondent receives a base gross monthly salary of \$8,750 as a Manager with Silicon Valley Real Estate Group, plus a \$450 monthly stipend, and holds a California Real Estate Salesperson License with the capacity to earn commissions and bonuses.

Additionally, the guideline calculation for spousal support indicates that spousal support shall be set at \$0. A copy of the guideline calculation is attached below and incorporated into this order.

Respondent's Request for Order is DENIED as he failed to file an income and expense declaration and failed to provide a change of circumstances. All hearings involving child, spousal, or domestic partner support, both parties must complete, file, and serve a current Income and Expense Declaration (form FL-150) on all parties. (Cal. Rule of Court Rule 5.260.) Additionally, the supporting declaration submitted in a request to change a prior child, spousal, or domestic partner support order must include specific facts demonstrating a change of circumstances. (Ibid.)
