FL-26-00004 Stapp, Karin vs. Brooks, Leo

Petitioner's Request for Order for Voluntary Waiver of Preliminary Disclosure per Family Code Section 2017 (b)(3) is GRANTED as requested.

FL-26-00006 Gill, Elisha vs. Gill, Joshua

Petitioner's Request for Order, seeking child support, filed on January 7, 2026 is GRANTED. The orders are effective January 7, 2026.

Respondent is ordered to pay child support in the amount of \$1,477.00 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Arrears are payable at a rate of \$100 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Each party must pay 50% of child-care costs related to employment or reasonably necessary job training. Each party must pay 50% reasonable uninsured health-care costs for the children.

Respondent is ordered to pay spousal support in the amount of \$766 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Arrears are payable at a rate of \$100 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month.
