## Tentative Decisions for February 11, 2026

**Courtroom #1: Judge J. Omar Rodriguez**

**DV-25-00085      Ianniello, Ashley Brooke vs. Pitchford, James**

The parties reached a full agreement at mediation. The review hearing is off calendar. No appearances are necessary.

**FL-13-00457      County of San Benito vs. Eduardo C. Vargas**

The Request for Order, filed by Eduardo Vargas on August 18, 2025, is DENIED without prejudice due to his failure to prosecute the matter. Respondent, Vargas, failed to attend mediation without justification after being ordered to attend mediation.

**FL-18-00435      Woodall, Sabrina vs. Mendez, Irvin**

Petitioner's Request for Order for Rehearing, filed on January 5, 2026, is DENIED without prejudice. Petitioner failed to have Respondent served with the Request for Order. Instead, Petitioner served Mr. Alexander F. Hennessy by mail despite his Notice of Limited Scope Representation on October 13, 2025 that was limited to representation at the subject hearing and the preparation of findings and order after hearing. The Notice of Limited Scope states "5. The attorney named above is "attorney of record" and available for service of documents only for this issues specifically checked on pages 1 and 2. For all other matters, the party must be served directly."

**FL-24-00132**      **Ruiz Perez, Natalie vs. Barajas, Omar**

The parties must attend an appointment for child custody mediation on March 10, 2026 at 12:00 p.m. at the Self-Help Center at the Superior Court of California, County of San Benito. The hearing on the Request for Order is continued to March 18, 2026 at 8:30 a.m. in Department 1.

**FL-25-00004**      **Navarro, Raul vs. Vallejo, Corrina**

The Request for Order, filed by Respondent, on January 6, 2026, is DENIED without prejudice due to her failure to prosecute the matter. Respondent failed to have Petitioner served with the Request for Order.

**FL-25-00076**      **Parra, Kim vs. Parra, Joe**

The trial setting is continued to March 4, 2026 at 8:30 a.m. to be heard with Petitioner's Request for Order filed February 4, 2026.

**FL-25-00253**      **Rojas, Michael vs. Rojas, Krisaundra**

The Request for Order, filed by Petitioner, on November 25, 2025, is DENIED without prejudice due to his failure to prosecute the matter. Petitioner failed to have Respondent served with the Request for Order and failed to attend mediation without justification.

**FL-25-00245**      **Valenzuela, Charlene vs. Valenzuela, Carlos**

The matter was previously continued to allow Respondent to retain counsel and file an income and expense declaration. To date, Respondent has not filed a substitution of counsel nor has he filed an income and expense declaration. Therefore, the Court makes the following orders regarding Respondent's request for Spousal Support.

Petitioner's Request for Order regarding Spousal Support is GRANTED. The Court adopts Petitioner's Proposed xSpouse Calculation as the Court's order. Spousal support is set at \$1,654 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. The orders are effective retroactive to

November 10, 2025. Arrears are ordered to be paid at a rate of \$250 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month.

The court used a printout of a computer calculation and findings, which is copied below and incorporated in this order.

Petitioner's Request for Control of the Residence is DENIED without prejudice as Petitioner has not provided a factual basis. (See Family Code §753.)
