## Tentative Decisions for July 1, 2026

**Courtroom #1: Judge J. Omar Rodriguez**

**FL-17-00049      Barkdull, Cristina vs. Barkdull, Damon S.**

Respondent's May 26, 2026 Request is GRANTED. The Order After Hearing, filed May 14, 2026 does not explicitly state that at all other times, the child shall be with Respondent. The Order After Hearing does state that Respondent, Father, is the primary residential parent (See Recommendations Paragraph 2) and that the Petitioner, Mother, shall have parenting time on specified weekends (See Recommendations Paragraph 3), with the implication that at all other times, the child will be with Respondent. The Court now clarifies that at all other times not otherwise specified in the May 14, 2026, Order After hearing, the parenting time with the child shall be with Respondent.

**FL-24-00073      Shepherd, Wendy vs. Shepherd, Gregory K**

Petitioner's May 28, 2026 Request for Order is GRANTED in part.

Petitioner's request for spousal support is granted. Respondent is ordered to pay spousal support in the amount of \$2,243 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Arrears are payable at a rate of \$100 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month.

The court used a printout of a computer calculation and findings, which is located below and incorporated in this order.

Petitioner’s request to sell the property is denied. Petitioner contends that the parties had agreed to sell the residence located at 320 McCarthy Street, Hollister, California. Although no order after hearing was submitted by either party, the minute order from November 21, 2025, indicates the parties agreed that Petitioner would assume the mortgage loan. If Petitioner was unable to assume the mortgage loan, her father would assume the loan. There was no agreement to sell the residence in a manner that Petitioner contends.
