FL-21-00115 Maldonado, Roy Anthony vs. Barrera, Jessica

The hearing on Respondent's Request for Order that was filed April 15, 2026 is continued to August 19, 2026 at 8:30 a.m. The parties are ordered to child custody mediation on July 1, 2026 at 12:00 p.m. at the San Benito County Superior Court's Self-Help Center.

FL-23-00164 Borch, Theresa Renee vs. Borch, Allan Harold

Petitioner's Request for Order, which was filed April 21, 2026, is GRANTED as requested. Spousal support arrearages total \$4,812.32. Respondent's response addresses the property division but does not acknowledge that there was an agreement between the parties that the property distribution would offset any spousal support payments owed. The arrearages owed must be paid within 60 days after service of the order. An income withholding order shall issue.

Petitioner's request to order Respondent to stop using Petitioner's residential address for personal, or legal financial purposes is granted as well.

FL-25-00079 Cervantes, Maricela vs. Leon Aguilar, Fransisco Javier

An entry of default has been entered against Respondent. Petitioner seeks a determination of property division for purposes of judgment. The matter is continued to August 19, 2026 at 8:30 a.m. Petitioner is referred to the San Benito County Superior Court's Self-Help Center for assistance to obtain a judgment in this matter. If judgment is entered

prior to the next hearing, the next hearing will be vacated and no appearances will be necessary.

FL-25-00213 Martinez-Palacios, Mark Jr vs. Martinez-Palacios, Victor

Petitioner's April 10, 2026 Request for Order is GRANTED. The parties reached a full agreement at mediation regarding custody and visitation. The remaining request pending is Petitioner's request to consolidate casers FL-25-00213 and FL-26-00078. The request is granted and case FL-25-00213 shall be the lead case.

FL-26-00054 Guardeno, Jasmine vs. Gallo, Michael

Petitioner's February 27, 2026 Request for Order is GRANTED.

Respondent is ordered to pay child support in the amount of \$199.00 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. The order is effective March 1, 2026. Arrears are payable at a rate of \$50 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Each party must pay 50% of child-care costs related to employment or reasonably necessary job training. Each party must pay 50% reasonable uninsured health-care costs for the children.
