Tentative Decisions for May 06, 2026

Courtroom #1: Judge J. Omar Rodriguez

FL-20-00055 Morcate, Jennifer vs. Morcate, Carl

Petitioner's March 4, 2026, Request for Order is DENIED. Family Code section 2108 requires a showing of unreasonable market or investment risk. Here, the concerns to the property and bank account relate to accumulation of garbage around residence.

FL-25-00153 Duits-Chapman, Dustin vs. Chapman-Duits, Michael

Petitioner's Request for Order, seeking child support, filed on March 20, 2026, is GRANTED. The orders are effective March 20, 2026. The request to continue the matter so that the support orders can be delayed until the request for visitation is addressed first is denied.

Respondent is ordered to pay child support in the amount of \$134.00 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Arrears are payable at a rate of \$100 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Each party must pay 50% of child-care costs related to employment or reasonably necessary job training. Each party must pay 50% reasonable uninsured health-care costs for the children.

Respondent is ordered to pay spousal support in the amount of \$1,285 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Arrears are payable at a rate of \$100 per month. One-half of
