Tentative Decisions for December 3, 2025

Courtroom #1: Judge J. Omar Rodriguez

FL-11-00517 Crowe, Natalie vs. Morris, Steven

Due to the parties' failure to attend mediation, the matter is taken off calendar.

FL-24-00059 Granados Lopez, Norma Angelica vs. Mijangos, Armando Aguilar

Petitioner's Request for Order, filed October 15, 2025, is GRANTED as requested. Respondent is ordered to immediately pay \$1,050 in arrears for the Toyota C-HR plus 10% annual interest from the date each payment was due until paid. The Clerk of the Superior Court or the Clerk's authorized representative is appointed as an elisor to sign the QDRO which was attached to the Request for Order as Exhibit 2. Within 10 days after receiving this order, Respondent is also ordered to reimburse Petitioner for the \$465.75 in costs incurred in bringing this enforcement action and \$275 in his share of the QDRO cost.

FL-24-00128 Villar, Seth vs. Mariano, Valeria

Due to the ongoing related case, the Court suspends the proceedings in this case and sets a status conference to be heard on January 21, 2026, at 8:30 a.m.

FL-24-00216 **Rivera Flores, Carla Jose vs. Bonilla Otero, Samuel Elias**

Petitioner's Request for Order Voluntary Waiver of Preliminary Disclosure per Family Code Section 2017 (b) is DENIED because Petitioner did not file a proof of service. This denial is made without prejudice.

FL-24-00239 **Franco, Gregory John vs. Perales, Deborah Ann**

Petitioner's October 15, 2025 Request for Order is DENIED without prejudice due to Petitioner's failure to file a proof of service.

However, the Court will amend the Judgement to reflect the correct date that the Court acquired jurisdiction, which is November 9, 2024. No appearances are necessary on December 3, 2025. Finally, in light of this tentative ruling, Petitioner's Request is moot.

FL-25-00094 **Valenzuela Llamas, Cristina vs. Torres, David Robles**

Respondent did not file a proof of service indicating that Petitioner has been served with the new hearing date. Petitioner was served with the initial Request. The hearing on Respondent's Request for Order is continued to January 21, 2026, at 8:30 a.m. Respondent to provide notice of the new hearing.

FL-25-00102 **Solorzano, Esther vs. Solorzano, Rodrigo**

Petitioner's Request for Order for Post Judgment Spousal Support is DENIED without prejudice. Petitioner did not provide any evidence regarding Respondent's earning capacity, supported spouse's contribution to the supporting spouse's education/career, needs of the parties based on the marital standard of living, assets/obligations of each spouse, age and health of respondent, and any other factors listed in Family Code section 4320.

FL-25-00130 **Caplette, Jeffrey vs. Caplette, Beverly**

Petitioner's Request for Order requiring Respondent to serve her Preliminary Declaration of Disclosure and file proof of service is GRANTED. Respondent is ordered to serve Petitioner with her Preliminary Declaration of Disclosure within 10 days after service of this order. Respondent is also ordered to file a completed Form FL-141 within 10 days after service of the order.

The Court will schedule a status conference on January 21, 2026 at 8:30 a.m. to review proof of compliance.

FL-25-00188 **Puentes, Ana vs. Puentes, Abel**

Petitioner's Request for Order Voluntary Waiver of Preliminary Disclosure per Family Code Section 2017 (b) is GRANTED.
