The matter is on calendar for Petitioner's October 6, 2025 Request for Order for custody, visitation, spousal support, child support and property control. The parties submitted a stipulation and proposed order that addressed custody, visitation, and property control.

The Court adopts the guideline calculation provided by Respondent in his Responsive declaration filed December 19, 2025. Respondent is ordered to pay child support at \$93 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Each party must pay 50% of child-care costs related to employment or reasonably necessary job training. Each party must pay 50% reasonable

uninsured health-care costs for the children. The order is effective October 3, 2025. Arrears are ordered to be paid at a rate of \$50 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month.

Regarding Spousal Support, the guideline calculation is set at \$0.
