**FL-25-00027                      Aguilera vs. Aguilera**

As a result of Petitioner's failure to file a Proof of Service and failure to attend mediation, the matter is continued to August 27, 2025 at 8:30 a.m. Petitioner to provide notice. Mediation is scheduled to take place on July 31, 2025 at 9:00 a.m.

**FL-24-00089                      Aldarondo vs. Delgado**

Petitioner's Request that Respondent provide a preliminary declaration of disclosure under Family Code section 2104 is GRANTED. Respondent is ordered to serve on Petitioner a code compliant preliminary declaration of disclosure by July 23, 2025. The court reserves jurisdiction to determine any sanctions pursuant to Family Code section 2107. The matter is continued to August 13, 2025 at 8:30 a.m. to review compliance with this order and address the request for sanctions.

**FL-25-00088                      Baltazar Jimenez vs. Campozano**

As a result of Petitioner's failure to file a Proof of Service and failure to attend mediation, the matter is continued to August 27, 2025 at 8:30 a.m. Petitioner to provide notice. Mediation is scheduled to take place on July 31, 2025 at 12:00 p.m.

**FL-22-00016**      **Cabibi vs. Cabibi**

**FL-21-00177**      **Celio Castaneda vs. Garcia**

Petitioner’s Request for Order to Voluntarily Waive Disclosures is DENIED without prejudice. Petitioner failed to file a Proof of Service that demonstrates that Petitioner provided Respondent with notice of the hearing and request.

**FL-23-00180**      **Garcia vs. Terry**

Respondent’s Request for Order re Arrears Payments is DENIED without prejudice. Respondent failed to use Form FL-490 (Application to Determine Arrears), which is a mandatory form that is to be attached to Request for Order (Form FL-300).

**FL-13-00298**      **Hernandez vs. Cruz**

As a result of the cancellation of mediation, the matter is continued to September 3, 2025 at 8:30 a.m. Mediation is scheduled to take place on August 5, 2025 at 9:00 a.m.

**FL-05-00127**      **Parsons vs. Parsons**

The Court has reviewed the Response by DCSS and the availability of counsel for DCSS. The matter is continued to August 13, 2025, at 1:30 p.m.
