Petitioner's August 28, 2025 Request for Order is denied without prejudice due to Petitioner's failure to prosecute the matter. The matter was previously continued to allow Petitioner to serve Respondent the Request for Order and for the parties to attend mediation. To date, Petitioner has not served Respondent and, as a result, mediation has not occurred.

FL-21-00240 DeFranco-Soto, Jeannie vs. Soto, Hugo

Petitioner's Request for Spousal Support is GRANTED in the amount of \$873.00 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month.

The orders are effective on November 19, 2025. The spousal support obligation will terminate after Petitioner has paid spousal support payments to Respondent for 4 years and 1 month, which is based on the September 27, 2011 date of marriage and December 1, 2019 date of separation.
