FL-23-00087 Anthony, Alyssa vs. Espinoza, Joshua

In light of the cancellation of the mediation that was supposed to take place October 14, 2025, the hearing is continued to December 3, 2025 at 8:30 a.m. in Department 1.

The parties are ordered to attend mediation on November 19, 2025 at 12:00 p.m. at the Court's Self-Help Center.

FL-23-00257 Toscano, Maria vs. Gonzalez, Carlos Lezama

The Petitioner's Request for Order is DENIED without prejudice due to Petitioner's failure to have Respondent served with the Request.

FL-25-00047 Quintero, Aida vs. Quintero, Adrian

Petitioner's Request for Order for Voluntary Waiver of Preliminary Disclosure per Family Code Section 2017(b) is GRANTED as requested. The Self-Help Center shall prepare the order after hearing. No appearances are necessary.
