Tentative Decisions for October 22, 2025

Courtroom #1: Judge J. Omar Rodriguez

FL-24-00244 Bautista, Dorinda vs. Orozco-Chavez, Julio

Petitioner's Request for Order (filed July 3, 2025) regarding Child Support is DENIED without prejudice. Petitioner never filed an Income and Expense Declaration despite the Court's statement on September 3, 2025, indicating that the Court would not issue child support orders if Petitioner does not file an Income and Expense Declaration.

The parties came to a full agreement at mediation regarding custody and visitation. Unless there is an objection to this tentative decision, the hearing on October 22, 2025, will be vacated and no appearances are necessary.

FL-24-00257 Velarde, Jasmine vs. Mendoza, Adam

In light of the new mediation date of November 19, 2025 at 9:00 a.m. which had to be scheduled due to the mediator's absence on the original mediation date, the Court vacates the hearing regarding custody and visitation. The hearing on December 10, 2025 at 8:30 a.m. shall remain on calendar as previously scheduled.

FL-25-00059 **Castaneda, Norma vs. Hernandez Reyes, Uziel**

Petitioner's Request for Order requiring Respondent to provide insurance to Petitioner is GRANTED. Petitioner asserted that Respondent cancelled Petitioner's insurance in violation of Family Code section 2040. Respondent is ordered to immediately reinstate the health insurance coverage or obtain a new policy with the same coverage as Petitioner had before the cancellation. Respondent is also responsible for paying Petitioner for any out of pocket expenses Petitioner incurred as the result of the cancellation.

FL-25-00146 **Dominguez Martinez, Leonardo, vs. Osorio Vasquez, Elisea**

The Department of Child Support Services ("DCSS") has substituted into the case. The Court had previously scheduled the matter to be heard on November 10, 2025 at 1:30 p.m. in Department 2 in case DCSS substituted into the case. The hearing on October 22, 2025, is vacated. No appearances are necessary. The November 10, 2025 at 1:30 p.m. hearing remains on calendar as previously scheduled.

FL-25-00159 **Guardian, Alma vs. Rivas, Josue**

Petitioner's Request for Order filed August 15, 2025, regarding Child Support, is DENIED without prejudice. On September 3, 2025, both parties were ordered to file their respective Income and Expense Declarations no later than October 8, 2025. Petitioner failed to file an Income and Expense Declaration despite filing the Request on August 15th.

FL-25-00181 **Guardeno, Jessica vs. Gomales, Guadalupe**

Respondent's Request for Order filed August 15, 2025 is DENIED without prejudice. Respondent failed to have the Request served on Petitioner, failed to attend mediation and failed to file an Income and Expense Declaration despite the fact that Respondent is seeking an order regarding child support.
