# **Tentative Decisions for October 8, 2025**

Courtroom #1: Judge J. Omar Rodriguez

### FL-19-00174 Kent, Tara vs. Kent, John

Petitioner's Request for Order is DENIED in part.

Petitioner's Request to extend Spousal Support is without merit. The Judgement, which was entered into in 2020, clearly states that the agreement regarding spousal support was payable through December 6, 2025, at which time there shall be no reservation of jurisdiction by the Court to award spousal support at any later time. The waiver of future spousal support was made in consideration of mutual promises, conditions, and agreements in the judgment.

Petitioner's Request for Child Support Arrears is denied without prejudice. Respondent failed to use Forms FL-490 (Application to Determine Arrears) and FL-420 (Declaration of Payment History), which are mandatory forms that must be attached to Request for Order (Form FL-300).

#### FL-20-00165 Jaime, Cristal vs. Jaime, David

Petitioner's Request for Order is denied without prejudice due to Petitioner's failure to prosecute the matter. The matter was previously continued to allow Petitioner to serve Respondent the Request for Order and for the parties to attend mediation. To date, Petitioner has not served Respondent and, as a result, mediation has not occurred.

#### FL-25-00067 Ramos, Candy vs. Ramos Jr., Joseph

Petitioner filed Requests for Order on May 22, 2025 and August 7, 2025 seeking orders regarding custody, visitation, child support and arrears, spousal support and attorney's fees.

The parties reached a full agreement via mediation regarding custody and visitation.

The Department of Child Support Services filed a responsive declaration requesting that the child support portion of the request be heard before the commissioner because there is an open case with DCSS. As a result of the request, the matter is continued to November 13, 2025 at 8:30 a.m. in Department 2 to address child support and spousal support pursuant to Family Code section 4251.

The request for attorney's fees is denied without prejudice as there was no declaration or information submitted in support of the request.

No appearances are necessary on October 8, 2025.

### FL-25-00107 Perez, Jovany Adalid vs. Perez, Samantha Marie

Respondent's Request for Child and Spousal Support is GRANTED. The orders are effective on the date that the parties are no longer cohabitating with each other.

Petitioner is ordered to pay child support at \$1,216 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. Each party must pay 50% of child-care costs related to employment or reasonably necessary job training. Each party must pay 50% reasonable uninsured health-care costs for the children.

Petitioner is ordered to pay spousal support at \$380 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month.

The court used a printout of a computer calculation and findings, which is located below and incorporated in this order.

All other requests contained in Respondent's May 29, 2025 Request for Order have been addressed by order and/or mutual agreement.
